Real Estate Finance (Portland)

Real Estate Finance (RE 521) will introduce fundamental concepts, principles, and analytical techniques of real estate investment and finance. This will include characteristics of commercial real estate market and real estate as a financial asset, investment strategies, proforma statements and financial spreadsheet modeling, data analytics, project evaluation, risk management, and more. The course emphasizes technology and real estate analytics using tools such as Excel, Tableau, and CoStar.

The course will be taught by Julia Freybote, Assistant Professor of Finance and Real Estate at Portland State University, and is open to current PSU students as well as non-degree seeking students.
